

USEFUL INFORMATION



CANCELLATIONS AND REFUNDS: the passenger has the right of withdrawal, with the obligation of informing Adria Ferries in writing of said withdrawal. The terms and conditions of cancellation are as follows:

- Up to twenty days before departure, 80% of the ticket price will be refunded.
- From nineteen days and up to five days before departure, 70% of the ticket price will be refunded
- From four days and up to one day before departure, 50% of the ticket price will be refunded.
- No refund will be paid on cancellations made after these times. Said regulations also apply to open tickets. Passengers who do not arrive for embarkation, but have not cancelled the journey, will not be entitled to any refund. Refunds are made exclusively in the country of issue of the ticket, through the issuing office, provided that the relative cancellation has been registered in the electronic procedure.

LUGGAGE: Foot passengers may only bring hand luggage. Passengers travelling with accompanying vehicles are allowed to leave their luggage in their cars. A paid luggage deposit service is available on some vessels.

ANIMALS: Passengers may bring pets with them. For the regulations on animals on board, read the PDF document available on the shipping company's website (www.adriaferries.com).

CHECK-IN: Passengers who have already booked, even if they hold a ticket, must go to the embarkation agency at least three hours before the departure time for the check-in procedures and security checks. If passengers arrive late, the company reserves the right to cancel the corresponding bookings and accept other waiting passengers.

COMMERCIAL VEHICLES: For bookings and information on loading of commercial vehicles being exported, used to transport goods or containing goods subject to customs formalities, contact the cargo office at our call center: +39-071 50211621 or read the information on the official Adria Ferries website (www.adriaferries.com).

DOCUMENTS: Passengers must have a passport or other document valid for foreign travel. The company therefore may not be held liable if passengers without a document valid for foreign travel are unable to travel and no refund will be due in this case.

TIME ZONE: The departure and arrival times are indicated in local time and are intended as pilot pick-up station to pilot pick-up station. Itineraries and timetables are subject to

change without prior notice. The company may not be held liable for sudden changes due to cases of force majeure or technical reasons.

OPEN TICKETS: Open tickets are valid for one year from the issue date. Any differences in rates must be paid by the passengers. The envisaged penalties and refunds will be applied in the case of cancellation.

PREGNANT WOMEN: Pregnant women who have already completed the 24th week of pregnancy will not be allowed to embark. Passengers who have not completed the 24th week of pregnancy are required to present a written medical certificate on board, issued no earlier than 72 hours before departure. This certificate must expressly authorise travel and must be handed to the ship's officer. By embarking, pregnant Passengers accept the risks associated with the absence on board of (specialist) assistance and appropriate facilities to manage any emergencies associated with their pregnancy, and also with the specific features of carriage by sea and the consequent difficulties in access to external assistance, and therefore may not hold ADRIA FERRIES S.p.A. and the crew liable in any way.

PASSENGER INFORMATION: The Passenger must provide the following information: first name, surname, gender, age, etc. All embarking Passengers must provide the Company with information on any need for special treatments and/or assistance in emergencies. Passengers who require assistance during embarkation (people with impaired mobility, etc.) must arrive ahead of time for embarkation and indicate their needs to the dockside staff and/or crew. Passengers must communicate any changes in the personal data if it changes between the moment of booking and the moment of embarkation. Personal data is collected pursuant to Italian Decree Law no.251/99, which transposes Directive EEC no. 98/41 of 18.06.98, the regulations on application of the ISPS code on anti-terrorism laws, and also in compliance with Decree Law no. 196/03. Pursuant to and in accordance with Arts. 22 and 23 of Regulation (EU) no.1177/2010 (on the rights of passengers when travelling by sea and inland waterways), passengers waiting to embark on the motor vessels of Adria Ferries are informed that said regulations may be consulted at the ticket offices of ADRIA FERRIES S.p.A. and on board the vessels. Said Regulation (EU) no.1177/2010 may also be consulted, in PDF format, on the website of the company (www.adriaferries.com).

COVID-19: the passenger is responsible for checking the necessary conditions to travel with the competent authorities before purchasing the ticket. All information on travel restrictions and the relative documentation can be consulted on the website www.adriaferries.com/it/news-adria-ferries.

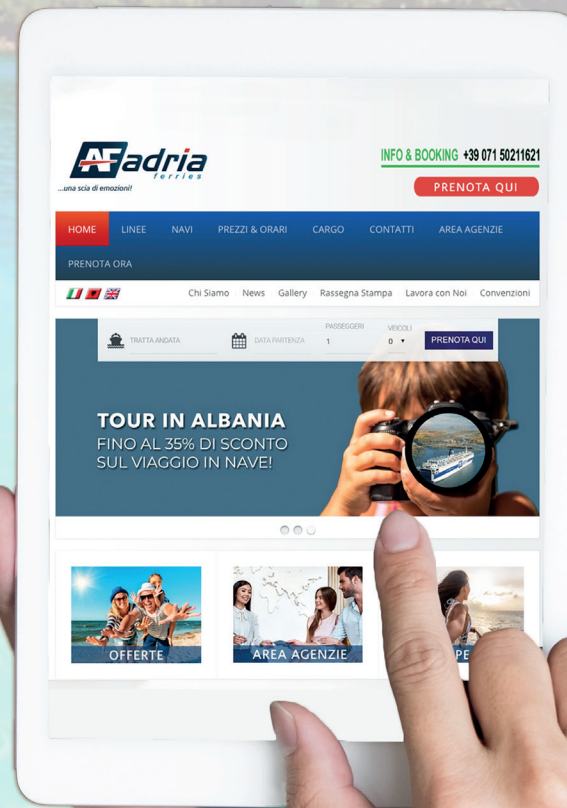
