



INFORMATION ON PROCESSING OF PERSONAL DATA
pursuant to Art. 13 of Regulation (EU) no. 679/2016

1. Subject

This information is provided pursuant to and in accordance with Art. 13 of Regulation (EU) no. 679/2016 (“GDPR”), in order to inform you that, in implementation of the guidelines issued by the Office of the President of the Council of Ministers, the Regional Authorities concerned and the competent health authorities to limit the spread of the COVID-19 virus (so-called “Coronavirus”), before embarkation and during the time spent on board Adria Ferries vessels, your personal data is processed, including data that could reveal your state of health, in accordance with applicable regulations and in respect of your rights.

Your personal data is processed before you embark, when you provide self-certification by filling out a questionnaire.

2. Controller

The Controller of your personal data is Adria Ferries S.p.A. with registered office at Lungomare Vanvitelli no. 18, 60121 Ancona (AN), Italy. You can contact the Controller at privacy@adriaferries.it.

3. Types of personal data processed, purposes and legal basis of processing

The processing relates to:

- (i) your common personal data (potentially including data on your movements);
- (ii) special categories of personal data relating to you, pursuant to Art. 9 of the GDPR, and specifically data that could reveal your state of health.

Processing of this data is necessary for the reasons of public interest identified by Decree Law no. 6/2020, as supplemented by the Decree of the President of the Council of Ministers of 23/02/2020 and by the orders passed by the following Regional Authorities, in conjunction with the Health Ministry: Lombardy (20/02/2020); Veneto (23/02/2020); Friuli Venezia Giulia (23/02/2020); Emilia Romagna (23/02/2020); Liguria (23/02/2020); Tuscany (23/02/2020); Campania (24/02/2020). This processing is lawful pursuant to Arts. 6(1), lett. c), d), e) and 9(2), lett. h) and/or i) of the GDPR.

Processing is performed as a purely precautionary measure, in accordance with the guidelines issued by the competent health, government and regional authorities to prevent the spread of the Coronavirus.





4. Methods of processing and storage of personal data

The data is processed by automated means and/or manually. Your personal data is not communicated to third parties or otherwise disclosed, unless this is (i) necessary in order to limit spread of the Coronavirus; and/or (ii) required by law, by secondary sources of law, the competent health authorities and/or the authorities responsible for laws on contagion containment.

You must provide your personal data in order to be allowed to board Adria Ferries vessels and access cannot be guaranteed if you do not provide it.

Processing of personal data is based, in any case, on the principles of proportionality and need, so unnecessary personal data will not be collected or processed. It is also based on the principle of lawfulness and transparency and compliance with the requirement of adequate security measures.

Your personal data will be erased thirty days after it is collected, unless specific obligations laid down by law and/or regulations and/or applicable circulars and/or the competent authorities require a different storage period.

5. Rights of data subjects

If you believe your rights have been infringed, you have the right to lodge a complaint with the Supervisory Authority (Art. 77) according to the methods indicated on the website of the Authority at: <https://www.garanteprivacy.it/web/guest/reclamo>, and also the right to an effective judicial remedy (Art. 79).
