

CANCELLATION AND REFUND

If the passenger chooses not to travel the following cancellation fees apply:

No cancellation fee if cancellation takes place the same day of the reservation
 Cancellation fee of 20% if cancellation takes place up until 20 days before departure;

Cancellation fee of 30% if cancellation takes place between 19 and 5 days before departure;
 Cancellation fee of 50% if cancellation takes place between 5 days and the day and before departure;

Cancellation fee of 100% if cancellation takes place 2 hours before departure or after departure

Passengers who do not show up at the departure gate without having requested the ticket cancellation beforehand, shall not be entitled to any refund.

Refund are only made within the issuing country, through the issuing company provided that the cancellation is registered in the online procedure.

LUGGAGE: Each passenger can only bring hand luggage. Passengers who travel by vehicles are allowed to leave their luggage inside their vehicle. Depending on the ferry, a luggage storage service for remuneration is available

PET: Company allows the passenger to travel with pets. About regulations on pet on board, kindly check the attached file given here below from Shipping Compa-ny website (www.adriaferries.com).

CHECK-IN: Passengers who have already purchased a ticket, must show up at the Port Agency at least three hours before departure for check in procedures and security check. In case of delay, the Company owns the right of cancel above-mentioned reservations and accept other passengers

DOCUMENTS: All passengers must have passport or an ID valid for expatriation and the Company must not be held responsible for passengers who cannot travel due to documents not in order, hence no refund is provided.

TIMETABLE CHANGES:

Departure and arrival timetable must be considered in local time and in pilot station.

Routes and timetables can change without notice. The Ship Owner must not be held responsible for sudden changes due to force majeure or technical issues.

OPEN TICKET: Open-date Ticket are valid for six months from issuing date. Any price variation must be managed directly by passen-gers. In case of cancellation and refund, cancellation fees will be applied.

PREGNANT WOMEN:

Pregnant women after 24 weeks are not allowed to travel. Pregnant women before 24 weeks must let issue a medical clearance issued not earlier than 72 hours prior departure. Above-mentioned certificate must explicitly authorize the

ability to travel and must be given to employee on board (professionals) and structure able to manage possible urgencies due to pregnancy, as well as specify transport by sea considering the difficulties to have external assistance, and also exemption of each and every responsibility of ADRIA FERRIES S.p.A. and everyone of its employee.

CONSUMER INFO: All passengers must provide information already upon reservation: name, surname, gender, age etc.

Any passenger requiring special aid and/or assistance in case of emergency is obliged to notify Transport Company thereof. Passengers in need for special help for embarkation (passengers with reduced mobility etc.) must appear within a reasonable time before departure in the harbour and communicate the staff on board resp. harbour the need of mentioned help Any change in regard to the aforementioned information


